- a). Discussion and Consideration for Landscape Enhancement Possible Plant Enhancement-Addition of Color
  - Racetrack Plant Enhancement 16 plants + 1 24" Vitex tree
  - Newport Plant Enhancement 5 plants Total of \$1,265.00
     Lorrie Mount moves to approve the proposal. Bryan Johnson 2<sup>nd</sup>. All in favor.
    - Hard Prune back of Texas Rangers both Racetrack & Newport \$4200.00
       Bryan Johnson moves to approve. Lorrie Mount 2<sup>nd</sup>. All in favor.
  - Rock Enhancement Consideration for Racetrack & Newport \$14,250
    - Possible consideration to phase into 2 year project
