Whether you are an owner-occupant or a landlord, you have the same responsibilities for your Murano property. When you purchased your property,



you signed many documents including the Declaration of Covenants, Conditions and Restrictions and Reservation of Easements for Murano Homeowners Association (commonly referred to as the CCRs) and the Bylaws for Murano Homeowners Association. *CONTINUED on Page 02...*

P&G Association Management and your Murano HOA Board work together to see that ALL owners abide by the Association's CCRs and By-Laws.

Murano's CCRs and By-Laws are in effect to protect <u>every</u> homeowner's vested interest.

Upon receiving a Violation Notice, it is in YOUR best interest to resolve the violation as soon as you receive notification. Fines will be levied if the violation is not corrected. <u>Unpaid</u> <u>fines will accrue until the total amount is paid</u> <u>off!</u>

If you are a landlord and have hired a property manager, be sure he/she has copies of the CCRs and By-Laws so he/she is aware of and can have tenants/prospective tenants agree to comply with both documents. Please be aware that the homeowner is ultimately responsible for any violations connected to his/her property.

As noted elsewhere in this newsletter, a noticeable increase in violation notices were sent out recently. Let's correct these violations quickly so that Murano looks as visually appealing as all of the new housing developments that are coming up around us!

### **Murano HOA Board Position**

One of Murano HOA's Board of Director's seat will be up for election during the summer. A nomination form will be in the mail soon.

## Weed Be Gone!

With the onset of Spring, many of our properties are being inundated with unwanted weeds! It makes for an unkempt look that negatively

affects Murano. All homeowners should make a concerted effort to keep their properties weed-free as it is a violation of the Murano Homeowners Association CCRs.



It would also be a great time to make a visual inspection of your bushes and trees to see if



they need your attention. Any dead bushes and trees should be removed and replaced. Trees that have overgrown branches that may be reaching over into your neighbors' properties and/or

touching your house should be trimmed back.

### **Synthetic Turf Installation**

At your Board's direction, Reveles Landscaping has completed the installation of synthetic turf in several of Murano's common areas in both quadrants! P&G Association Management is in communication with the Southern Nevada Water Authority (SNWA) for our HOA to receive a considerable rebate amount through SNWA's Water Smart Landscapes Rebate program. We hope to see a considerable drop in our common areas' water bills, too!

The turf has provided our children with a nice area to play in BUT it has created a situation where young children are being observed leaving bikes out on the streets when they are playing on the turf, trees are being climbed and branches broken, and personal items are *CONTINUED on Page 03...* 

#### **Hey, Pet Lovers!**
